By accessing or using ReadyVet, you agree to be bound by these Terms and Conditions, including any future updates or modifications. If you do not agree to these terms, please do not use the App.

Subscription and Payment

All payments are processed through a third-party payment gateway, Stripe. We do not store any bank details of our users.

User Accounts

Users are solely responsible for creating and maintaining their passwords, which ReadyVet cannot access or view. Passwords can be reset or changed by the user using their registered email address.

Upon login, users may request a one-time password to be sent to their registered email address for authentication purposes.
